Singapore follows a progressive resident tax rate starting at 0% and ending at 22% above S\$320,000. There is no capital gain or inheritance tax. Individuals are taxed only on the income

earned in Singapore. The income earned by individuals while working overseas is not subject to taxation barring a few exceptions.
